1. Registration Fee (non-refundable):

1. Refundable Security Deposit:

- a. The security deposit is \$100.00 for each student, which will be deducted from your payments.
- b. Deposit fee is not refundable for all cancellation.

2. Tuitions: (Monday-Friday, 8:30am-6:00pm)

4. Bounced Check Fee:

5. Refund Policies:

- a. Requests for refunds must be inwriting.
- b. Any cancellation received in writing or email (cccsummerschool@gmail.com) two (2) weeks prior to the first day of the session reserved will result in a 100% tuition refund. \$5 processing fee will be charged only;
- c. Any cancellation received in writing or email (<u>ccccsummerschool@gmail.com</u>) one (1) week prior to the first day of the session reserved, a 50% tuition refund will be issued;
- d. Registration fee and \$100 deposit fee are not refundable for all cancellation.
